No 3712 granted to the Said John Thompson by the Court of Commissioners in 1798 one other in the name of John Thompson for 100 acres Certificate No 18 Granted to him by Christian County Court in May 1801 one other in the name of John Thompson Snr for 200 acres Granted to him by Christian County Court No 1169 and granted Ap¹ 1803 one other in the name of John Thompson asse of Margret Thompson for 100 acres Cert^t No. 2742 which was granted to the s^d Margaret Thompson by the County Court of

Know all men by these presents that I John Thompson of the common wealth of Kentucky Christian county for and in consider of the sum of five Hundred Dollars lawful and Current money of the commonwealth afforesaid to me in hand by James Thompson of the same place well and truly paid at or before the sealing and Delivering of these presents the Receipt and payment whereof is hereby acknowledged hath Bargaine^d sold and deliver^d and by these presents According to a due form of law do bargain sell and deliver to him the following property (to Wit) one Waggon and four pare of geers with Iron chanes and suitable Double trees with a Log chain &c also thirty head of Neat cattle all Marked with a Crop off the Right Ear and a piece off the upper side of the left also seventeen Head of sheep Marked as afforesaid as also thirty head of Hogs with the same mark as also one Bay Horse Not Branded as also two large Skillits and one large pot and two Dutch ovens and one Skillet two Iron Pot Racks and one pair of tongs as also two Pewter Dishes and two basons with twelve Pewter Plates as als [sic] one large Walnut Chest and one Flax hackke one feather Bead and furniture with one pair of curtains of callico coloured blue and yellow as also two set of Barshear Plows Irons and one shovel Plow with two clevish [sic] Irons to Each Plow as also one spade and Mattock all which property as aforesaid I do by these presents warrant and Defend to the said James Thompson in his possession now being by Virtue of this Bargain and Sale from me and every and all and every other person or manner of persons in witness whereof and to these presents I the said John Thompson hath set my hand and affixed my seal this 7th of June 1808
