



Definitions and Suggestions

Definitions

This report has three sections:

1. The Print & Distribution Summary (one page) is intended for those involved in the production of the Newsletter. It gives the total number of documents needed for distribution, and the number to be distributed to each Area Contact.
2. The Distribution Summary pages (one per Area Contact) contain the names and phone numbers of each Block Contact in the Area, along with the Farringham Post (FP) numbers of all the lots in each block. These pages are intended to assist the Area Managers in counting and distribution to the Block Contacts the correct numbers of the printed material to be distributed.
3. The Block Contact(s) Distribution sheets (one per Block Contact in every area) has a list of all the FP numbers in the Block Contact's distribution area, and an indication of whether the lot is "No Paper Deliv." or has opted out of the print media being distributed ("Opt Out: Newsletter", for example), or, with no notation, the address should receive the printed material.

In the Block Contact(s) Distribution sheets, a notation of "No Paper Deliv." means that the FHA directory does not show anyone living at the address. This notation might be incorrect if

- Someone lives at the address, but has chosen not to be listed in the FHA directory; or
- The person(s) living at the address has not registered for a listing in the FHA directory because they did not realize they could. (New residents or renters may be invited to be listed in the directory.)

If the Block Contact is aware that someone lives in a residence marked "No Paper Deliv.", the Block Contact should invite the resident to register for the directory through a visit to the FHA office, or an email to directory@farringhamfha.org.

NOTE: Residences listed as "No Paper Deliv." and those listed as "Opt Out: Newsletter" (or "Opt Out: Directory", in the future) ARE NOT included in the totals for printing, or distribution to Area Contacts or Block Contacts.

Suggestions

The Block Contacts, if desired, can annotate their Block Contact(s) Distribution sheet and return to their Area Contact or otherwise provide the information to FHA to update listings. If an address is vacant, for example, or if someone tells the Block Contact they no longer wish to receive a newsletter, the Directory team can update the directory accordingly.
